The purpose of this letter is to respond the 2008/2009 Santa Barbara Grand Jury Report entitled, **SBCAG – A Road Not Taken.** The following responses to the findings and recommendations were approved by the City Council of the City of Guadalupe.

**Response to Findings:**

**Finding 1a.**

**SANTA BARBARA COUNTY ASSOCIATION OF GOVERNMENTS  
(SBCAG) HAS AUTHORITY TO DO REGIONAL LAND USE PLANNING  
THROUGH ITS JPA:**

The City of Guadalupe agrees.

**Finding 1b.**

**THE STAFF HAS DEVELOPED RECOMMENDATIONS FOR  
REGIONAL LAND USE PLANNING APPROVED BY SBCAG.**

The City of Guadalupe agrees.

**Finding 1c.**

**THE REGIONAL LAND USE PLANNING RECOMMENDATIONS  
ADOPTED BY SBCAG HAVE NOT BEEN IMPLEMENTED.**

The City of Guadalupe will work to focus on the recommendations at issue and understands the importance of each agency's role in implementing recommendations.

**Recommendation 1.**

**THAT SBCAG AND EACH RESPECTIVE JURISDICTION IMPLEMENT  
ALREADY ADOPTED RECOMMENDATIONS THAT DEAL WITH  
REGIONAL LAND USE PLANNING.**

The City of Guadalupe is aware of our responsibility in implementing recommendations at the local level. Policies and practices are in place that emphasizes the importance and obligation related to regional land use planning.

**Finding 2.**

**SBCAG HAS NOT DEVELOPED A FULLY INTEGRATED REGIONAL  
PLAN COORDINATING JOBS, HOUSING AND TRANSPORTATION  
THAT INCLUDES ALL THE COUNTY'S JURISDICTIONS.**

The City of Guadalupe agrees.

**Recommendation 2.**

**SBCAG DEVELOP A FULLY INTEGRATED REGIONAL PLAN.**

The City of Guadalupe agrees and is obligated as a member jurisdiction to be involved in responding to the State's Regional Land Use Planning requirements under SB 375. The City is fully participating in accordance with legislation to prepare Sustainable Communities Strategies (SCS) to address land use, housing and transportation.

**Finding 3.**

**SBCAG REFUSED TO APPLY FOR STATE FUNDS FOR  
COMPREHENSIVE REGIONAL PLANNING.**

The City of Guadalupe agrees that available grants should be tapped into for regional planning programs using combined efforts.

**Recommendation 3.**

**SBCAG AGGRESSIVELY PURSUE FUNDING FOR COMPREHENSIVE  
REGIONAL PLANNING:**

The City of Guadalupe agrees that funding related to regional planning may be worthwhile as long as matching requirements are clearly available.

**CONCLUSION:**

The City appreciates the Grand Jury's recommendations. Thank you for the opportunity to review and respond to the Grand Jury Report. We appreciate your assistance in the matter of regional land use planning.
