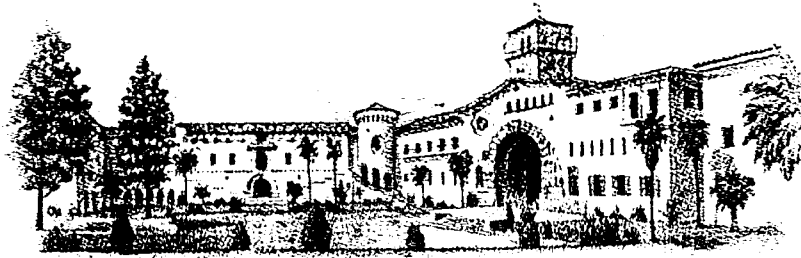

Dear Mr. Sten,

This letter is in response to your letter dated April 6, 2009 requesting an update on Recommendation #5 of the 2005-2006 Civil Grand Jury report.

The City's Response stated, "Decisions...are made at the Council level. Political battles affect staff and are a disappointment when politics present staff from working in the best interest of the public.

We are pleased to let you know the previous members of Council were voted out of office. The new Council has no animosity and puts the public first at all times. The spirit of cooperation with staff is a rewarding experience for our community.

Policies and procedures in place to ensure staff is able to work in the public interest include: a) Public Purchasing and Procurement Ordinance No. 2003-362 – Delineates a clear dollar value for consent and approval by staff versus Council. b) The hiring of a Human Resources officer – Reporting mechanism for employment workplace deficiencies and unethical behavior that result at all levels of governmental positions.

In addition, department head contracts include sanctions for employee's dishonesty, fraud, self-dealing, or willful misconduct as cause for termination.

CONCLUSION:

The City respects the Grand Jury's recommendations and we hope this response demonstrates our desire to maintain policies and procedures to protect the financial interests of our citizens. The City Council approved this response at the regular meeting of April 28, 2009. Please accept our sincere thanks and appreciation.
